The Summit Initiatives Committee

From the time ALI-ABA and ACLEA first began planning the Summit, both organizations were committed to implementing as many of the Summit's Final Recommendations as possible. Both organizations recognized, of course, that such an ambitious project as the Final Recommendations would require numerous partners across the profession. To begin the process, ALI-ABA and ACLEA formed a Summit Initiatives Committee, drawn from individuals who were deeply involved in the planning and execution of the Summit. This committee, which represents a broad spectrum of constituencies within the law, will meet to plan how the Final Recommendations can be best disseminated, put on the agenda of relevant groups, and then implemented. Among the issues it will consider are outreach to specific entities, additional research identified by the Final Recommendations, funding for implementation efforts, and longer-term structures for pursuing those implementation efforts.
